### 1. Report Out: Incorporating the Voices of People with Lived Experiences

*Moffit provided a summary of the survey conducted by Recovery Coalition of Dane County with people with lived experiences. In total, 45 people were interviewed. Based on results of the survey and feedback, the ideal way to access mental health services, with no barriers, would be a 1 stop shop for people to go to. Discussion occurred on the results, next steps, and alignment with the SIM model. Group will use the hand-out provided by Moffit, "Hurdles on the Road to Recovery," as a barometer in moving forward when providing recommendations/prioritizing gaps to ensure hurdles are not exasperated.*

### 2. Discussion of Focal Points of Concern Survey Results: Intercept 0 (community) & Intercept 1 (law enforcement)

*Reviewed and discussed the results of the survey. Top themes included: Lack of diversion options, need for a way to triage/lack of crisis center, diversity of providers, access to resources (long wait lists and after business hours), lack of communication between government organizations, law enforcement, and service providers, and lack of clarity of crisis service system to family members and people within the system.*

*Mbainai, from Corporation Counsel, reported the following information from 2018:*

- 457 mental health cases filed with the court
- 324 cases resulted in emergency detention which involves law enforcement
- 64 cases resulted in chapter 51 commitments
