Tim Black from CAHOOTS presented on the program. Crisis Assistance Helping Out on the Streets (CAHOOTS) is a client centered services, harm reduction model. A two person team comprised of a medic and crisis intervention worker are out in the field serving individuals in need. Types of services provided include: crisis counseling, suicide prevention, conflict resolution & mediation, grief & loss, welfare checks, substance abuse, housing crises, harm reduction, first aid and non-emergency medical care, resource connection and referrals, transportation services, and family disputes.
