1. Pretrial Services: Overview of Program and Gaps in Behavioral Health Services

Presented by Julie Beyler, Lead Social Worker of Pretrial Services Summary attached

Public Comment: Paul Saeman Susan Levy

Presentation explained the background, role, history, and purpose of Pretrial Services. Dane County Pretrial Services is led by social workers as they help in supporting individuals on pretrial release identify underlying behavioral health issues. Pretrial Services was originally a post-conviction electronic monitoring program, then moved to a bail monitoring program. Pretrial Services has re-evaluated its role recently, with assistance from the Public Safety Assessment (PSA), which allowed Pretrial Services to determine appropriate levels of supervision. Additionally, Pretrial Services has adopted new software to communicate with participants and revised their substance use testing protocol.

Discussion ensued regarding opportunities for behavioral health services within Pretrial Services. Discussion regarding peer support specialists and resources and Telehealth as a tool within Pretrial Services. Discussion around initiatives to reduce service gaps. There are challenges with placing defendants in behavioral health treatment programs because service providers are concerned that they will not be able to complete the program before incarceration.

2. Criminal Justice Diversion Collaboration

Presented by Sarah Shimko, Julie Foley, and John Christian Presentation attached

The presentation focused on practices for emergency detention with accompanying criminal charges. Previously, law enforcement had to take and accompany defendants to Winnebago. Recently, the practices have changed. The criminal intake unit receives email notifications for emergency detention cases, then reviews each case for associated charges for increased communication and centralized collaboration. Preference to keep services local in the community. Presentation also included preliminary data on diversion and monetary savings.

Discussion ensued regarding internal communication and interagency collaboration; different timelines across agencies. Distinction between charges and law enforcement roles compared to the roles of mental health service providers and the challenges with domestic violence charges were also discussed. Discussion of coordination with public defenders for remote initial appearances also occurred.

3. Behavioral Health Resource Center (BHRC) Update

Presented by Carrie Simon

The BHRC opened in November of 2020 and has assisted 284 people, with a steady trend upwards as more people learn about it. Three additional staff have been hired. Data is continuing to be collected. So far, there have been over 31,000 visits to the BHRC website. Other behavioral health professionals are also using the BHRC to refer their clients. Demand for automated follow-ups are low, but will increase with increased traffic. Although the BHRC is a referral point, it can also still take a long time to connect with behavioral health services. There is a high need for consultations and peer services. Co-location with NAMI enables peer services once in-person services resume.
