#### F. Presentations

#### 1. Mental Health Court Study

Paul Saeman registered late, asked to speak to the Committee. Chair asked if there was objection to letting Paul speak, no objection. Paul Saeman provided testimony.

Todd Campbell introduced UW Population Health Institute presenter Abra Vigna.

Vigna presented work on the mental health court study including recommendations.

Discussion and questions ensued.

Mbainai inquired about incorporating restorative justice. Vigna noted that it likely depends on what stage in treatment they are at. Philosophy behind it would suggest yes, but clinical considerations would need to be considered.

Mbainai asked about dual diagnosis. Vigna noted that it is important to increase capacity in order to better understand a dual diagnosis

Clark-Bernhardt inquired about arrest charges leading to incarceration. Asked about data that they went though. Vigna noted the data they had was not on the types of charges so couldn't look into it. Limited research about familiar faces.

#### **G.** Reports to Committee

1. Use of Peer Supports: Survey Results and Oral Report Out

Clark-Bernhardt asked members to report out, from their agency perspective, where opportunities and challenges exist regarding peer supports.

Chapin explained that peer support in law enforcement is used in their wellness program. For officers that have dealt with a critical incident or have things going on at home, there are trained peer support specialists available to offload some of the things officers are dealing with. They able to have a discussion about what they're dealing with and are able to offer resources.

Quite a few agencies in the County use some sort of model of peer supports.

Enger noted that DOC has peer supports.

Hyatt noted they have peer support groups in the organization and are looking to hire a peer support specialist.

Crawford reported that peer supports are used in the courts, but doesn't believe they are used in other contexts.

Campbell, from the Human Services Department, offered the following information in an email before the meeting regarding where peer supports are needed across the intercepts:

- o Add to the existing pool in the Crisis Unit, particularly those that could be available for mobile crisis response
- o Warm line
- o Pretrial services
- o Specialty Problem-solving courts (Drug Court, OWI Court, Veterans Court)
- o Community reentry from incarceration
