# 1. VIDEO OF DANE COUNTY COMMUNITY RESTORATIVE COURT

Question on details of how the Community Restorative Court (CRC) actually works, ie case processing, negotiation, and what happens on completion. Law enforcement agencies (half in the county have signed into agreement) and District Attorney's office can refer most misdemeanor charges with some exceptions. Question on if the forfeiture is the end result or part of the original charge. Question on which jurisdictions ordinance used to determine forfeiture charge.

*Further detail regarding Community Restorative Court available at prior CJRI meeting. Discussion on repair harm agreement* 

Question on the role of discretion when referring cases to the CRC. Question regarding potential time limit on allowing victim to be involved in a case.

Discussion on outreach and participation of victims by District Attorney and CRC office staff. Victims have the option of participating in the CRC.

Question on capacity to refer and review cases to the CRC. Information requested on the number and demographics referred to and participating in the CRC.

Comment on City of Madison law enforcement agency's two tracks for diversion. Any 12-16 year olds that receive tickets are automatically placed into restorative justice process. Written information requested on two tracks provided in City of Madison program.

Bill currently progressing in Dane County Board of Supervisors to support two additional staff for the CRC.

Question on if the CRC conducts sessions in Spanish and other languages.

# 3. DATA REVIEW (CORNELIUS)

## 2023 DANE COUNTY DATA FROM A SYSTEM LENS FOLLOW-UP PRES-091

#### Attachments: 2023 PRES-091

Presentation on data from system lens follow-up by Tamarine Cornelius. Topics include a review of cases with only non-violent charges with findings being nearly identical in terms of greatest disparity; data on resisting or obstructing an officer offense presented; findings on the likelihood of associated charges with most disparate offenses; data on black/white disparity rate ratio of ten most common offenses; data on the share of defendants (17-35) with previous criminal case filed in prior three years across race.

Comment on understanding if previous charge on cases for defendants potentially eligible for the Community Court is violent and the racial disparity measures for these cases. Comment on five out of eight charges have associated bail jumping charges and the importance of understanding if the original charge is violent.

Question on why the possession of a firearm charge is so disparate. Recommendation to discuss the underlying reason for these disparities further.
