1. Community Conversation - Shut the Front Door debrief

Clark-Bernhardt reports that Cherise Fanno Burdeen from the Pretrial Justice Institute came to Madison from 6/2-6/3/2019. She presented at a special session of the CJC meeting and a community conversation on 6/2. About 50 people attended. There were speakers from the local and state criminal justice system. The crowd responded positively, and people generally left knowing more than they knew coming in. Fanno Burdeen stated that this was the first time there has been this much open conversation about the impact of race and pretrial. McNamara reports that Fanno Burdeen also facilitated a meeting in the courthouse with judges and pretrial service staff.
