C. Presentations

1. Dane County Jail Population Manager

Presented by Michelle DeForest

Introduction to jail population manager. Main roles include: data collection, liaison to different stakeholders, examination of DCSO practices with an emphasis on evidence-based decision-making. Also collaborated and improved website to make it more transparent and accessible to community members. Jail population manager also reports monthly to several branches on pretrial holds, then work with the DA to make sure that they get to initial appearance. In the future, the jail population manager will collaborate with the CJC R&I team to collaborate on dashboards and on starting a jail population review team.

Discussion ensues. Importance of collaboration with different stakeholders. Jail population review team can be a relatively small, deliberate work group. JFA Institute has experience implementing these nationally and will assist DeForest and Dane County stakeholders.

Review of report of PSA data from 7/1/17 – 9/30/21. The statistics are relatively consistent with past data.
