# 1. MDRC Research in Dane County

Presented by: Melanie Skemer of MDRC

MDRC is a non-partisan, mission-driven research organization committed to finding solutions to some of the most difficult issues facing the nation, with the goal of improving the lives of individuals, families, children, and communities.

MDRC, supported by Arnold Ventures, has partnered with Dane County to conduct research and reform the County's pretrial justice system. There are two goals of the project:

- 1) Help partner jurisdictions assess the performance of their pretrial release interventions, with a focus on court appearance outcomes;
- 2) Identify the least burdensome pretrial supervision interventions necessary to maintain court appearance

There are two phases of the project. Phase 1 is a process and descriptive analysis and phase 2 are impact studies. To date, there has been a lot of progress made in phase 1 of the project; phase 2 has not started yet as it was postponed due to the COVID-19 pandemic.

Skemer reviewed phase 1 research activities and highlighted a list of data that has been provided by the CJC/Dane County. MDRC is currently analyzing court appearance trends. Phase 1 results are expected to be published in the Summer of 2021.

Discussion ensued regarding the Clerk of Courts Office sharing GPS data with various entities (law enforcement officers, attorneys, etc.). Corporation Counsel advised the Clerk of Courts Office that the GPS data may be considered an open record. Pretrial services is trying to limit data requests to active and ongoing investigations and direct requests. Some requests are very broad. There was discussion about whether or not to create a process to notify the Public Defender/DA/Judge/attorney when a request is made and whether or not a policy should be in place to make a formal request to access the data.

Clerk of Court Esqueda will provide data regarding the number of requests his office receives at the next subcommittee meeting.
