## **D.** Presentations

1. Summary of CJC-Behavioral Health Subcommittee Presentation Regarding Pretrial Services

#### Presented by Julie Beyler

Staff provided an overview of the attached report. Staff noted the use of the Public Safety Assessment (PSA) and how it has aided in decision making. Pretrial Services aims to help defendants end the program in a better position than when they started, particularly in the context of underlying issues. One of the biggest issues clients faces is being unhoused which makes behavioral health concerns more challenging to manage. Pretrial Services cannot impose treatment, staff can only suggest it and offer support. Insurance barriers continue to be a challenge.

Discussion ensued regarding the technical platform of the automated text messaging system. Subcommittee members also discussed implementing Peer Support Services throughout Pretrial Services. Discussion of the frequency and use of drug testing during COVID also occurred.

#### 2. PSA Quarterly Report – Feedback on Report Structure

#### Presented by Anadon

Subcommittee members discussed the structure of quarterly Public Safety Assessment (PSA) reports. Feedback on how to move forward and what variables to consider, including differences in judicial decision-making compared to PSA recommendation. Interest in examining data before versus during the COVID-19 pandemic to determine who is incarcerated and how their PSA assessments differ. Interest in examining long-term effects of COVID-19 on future nonappearance variables due to the impact of remote hearings during the pandemic. The data will be shared in an online format in the future.

## 3. 2020 RES-177 Initial Analysis Feedback

#### Presented by Reyes and Clark-Bernhardt

Staff provided an overview of the upcoming presentation to the Public Protection and Judiciary Committee on cash bail. The same presentation was shared with the Criminal Justice Council (CJC) at its March meeting. The analysis looks at trends on the individual level and can be used to understand the pretrial justice system.
