1. COMMUNITY RESTORATIVE COURT UPDATE (CRC Staff)

Presented by CRC Staff: Stephanie Marino See attached document.

The Community Restorative Court continued successfully throughout the pandemic. There was a 70-case decrease during the pandemic, with only 9 terminations for all of 2020. The CRC is also doing its first circle with only Spanish-speakers, led by Spanish-speaking peacemakers. The CRC plans to transition trainings to in-person, rather than remote, as full vaccination increases. There are a number of police departments that have signed onto the CRC MOU but have not referred defendants. CRC staff have followed up with those agencies.

2. AGENCY COVID-19 RESPONSE AND FUTURE PLANS

Discussion: What has changed in subcommittee members' processes and practices in response to the pandemic? What has worked well? How can the CJC-RD Subcommittee help transform the beneficial changes in process and practices into long-term, sustainable changes?

Discussion of policy changes during the COVID pandemic. Out-of-custody video visits seem to be successful, and may be continued into the future for brief appearances, as they are more convenient for defendants and reduces concerns about scheduling, missing work, childcare, etc. This has had an increased appearance rate in juvenile court as well and enables more people to attend meetings. This also has benefits for the Community Restorative Court, especially for volunteer peacekeepers. In-custody defendants must be allowed to make in-person appearances, particularly for substantial hearings. Law enforcement discretion on warrant enforcement may be worth revisiting. There may be more future deflection opportunities through these mechanisms.

3. UPDATE ON COMMUNITY JUSTICE CENTER NEEDS ASSESSMENT AND PLANNING: NEXT STEPS (STAFF)

The deadline for proposals for the Community Justice Center Needs Assessment RFP was February 24th, 2021. The evaluation team, composed of Ozanne, Clark-Bernhardt, Kostelic, and Chance, reviewed proposals closely and made a unanimous decision with one vendor scoring consistently high. They are currently drafting a contract with the vendor. Once the contract is signed, this information will be publicly available; this should occur in early April. Seven nonprofit groups testified at the last CJC meeting, and their testimony was compiled into a short YouTube video (linked).
