# CONTINUED DISCUSSION AND POSSIBLE ACTION BY SUBCOMMITTEE ON WORK ITEMS/TOPICS TO PRIORITIZE FOR CJC IN 2021 [NOTE: See Minutes file for notes on March 2021 CJC-RD topics brainstorm]

Review of CJC-RD topics brainstorm [See attached summary document].

Discussion regarding data dashboards, such as that created by Milwaukee District Attorney's Office. Discussion of violence prevention as a priority. Resource allocation will be challenging because in-person trials are resuming in June. Funding opportunities through grants can be expedited now while resources are limited. Potential juvenile justice detention initiatives. Potential initiatives should be grouped into categories and presented as a draft to the CJC to determine next steps.

### PRESENTATION BY PHMDC ON ITS VIOLENCE PREVENTION PROGRAM AND EFFORTS (Aurielle Smith)

Presentation by PHMDC's Aurielle Smith of the roadmap toward violence prevention, with data to inform practices. Emphasis on supporting and engaging families, neighborhoods, and promoting healing and intervention. Coordination between agencies to prevent violence is crucial in this initiative.

Discussion centered on the use of schools and communities to provide healing supports to youth and city and county collaboration on this initiative. Emphasis on partnerships between agencies and communities. Intend to use quantitative and qualitative data, with law enforcement and other agencies' data. Discussion regarding the timeline for initiative implementations, availability of programming, and focus on protective factors.
