#### 1. COMMUNITY RESTORATIVE COURT UPDATE

Presented by Stephanie Marino

Review of CRC updates. Review of data on referrals by race by law enforcement agency. Discussion of DA's eligibility screening and referral process to CRC. Challenges of wait list, multiple co-occurring cases, and case processing time. The CRC has increased its capacity in bilingual and bicultural staff, supports, and service providers.

The Office of Justice Reform and Equity (OJRE) is still in the process of hiring a director. Once the director is hired, then OJRE will proceed with hiring of additional staff, including the Community Court coordinator. Office space has been identified. The Community Court will be a substantial part of OJRE, and they will receive technical assistance from Center for Justice Innovation (formerly Center for Court Innovation). The Community Court Advisory Subcommittee may potentially complete two site visits to learn from mentor courts.
