Ryan Moorad shared a presentation about the Assessment, Treatment, Transition, and Aftercare (ATTA) Program, an initiative designed to provide intensive, community-based support for at-risk youth and reduce the need for placement in state correctional facilities. Discussion ensued regarding:

- Additional resources that could be integrated into ATTA services Staff speak Spanish and ASL.
- The program is not at capacity. Capacity is expected to increase in the future.
