#### January Advisors---Data Analysis

Jeff Reichman from January Advisors presented on a data analysis January Advisors will be completing. January Advisors have worked with criminal justice agencies in Texas with a focus on the impact of diversion and deflection policies. They work to determine where new programs can help to reduce jail population. Reichman will interview stakeholders to gain insight into the Dane County criminal justice system. Discussion of defining low-level felonies and population who can be diverted ensued. More conversation to be conducted one-on-one.

#### Arrest Report

Clark-Bernhardt and Reyes presented on arrest data. The CJC discussed the challenges of defining arrest and police contact — decision to use public understanding of custodial arrest, regardless of charges. Presenters noted that this does not include all calls for service, because many calls for service do not result in any legal action. Demographics and size of populations served by different police departments will be taken into account in future reports. The high missing rate of data on ethnicity will also be considered in future reports. Future research will also examine the individuals who had 3 or more contacts in one year. The CJC discussed the positive learning experience through cross-agency data collaboration. There was discussion of adding the Dane County Sheriff's Office in future iterations.

#### MacArthur Foundation Project Update

Clark-Bernhardt provided an update on the Capstone Project and the Safety and Justice Challenge (funded by MacArthur). In September, community conversations occurred through the Capstone project with speakers Clark-Bernhardt, Ozanne, Esqueda, and Tye (not present). The speakers at the community conversations said it was a positive experience, community had lots of interesting and complicated questions and issues, and noted it would have been nice to have had a longer time dedicated for conversations following the brief presentations.
