Propose to follow Red Hook model

Best of both worlds

Decrease jail population further than other initiatives

Cost unknown, but timeline - could open at same time as new jail

Transitional Housing options, juvenile justice options, are all included under one roof.

Discussion arises around what would be included in the community justice center and timelines. Specialty Courts were also discussed.

Biggest issue in system is trust in the system. Hasn't really changed racial disparities. Want to make a community justice center, not change current practices. Need a space in the community. Services right next door—not disconnected. Competency restoration.

Discussion ensues around the need for a change and partnerships.

Grant to look into needs assessment, see if it's feasible

1. 2019 COMMUNITY ALTERNATIVE PLAN FOR HOUSING, HEALTH CARE, RES-067 AND DECARCERATION

Supervisor Heidi Wegleitner presented, co-sponsored, community alternative plan for housing, health care, and decarceration; working over next month to see what benchmarks are going to be; similar to 87; want to merge the two together. She brings up for discussion today, not a vote. Need additional perspective of lived experience and behavioral health care. Discussion ensues around specific areas in the proposed resolution.

Goal to take ADP down by 350 by 2025

How did this become the target? Heard from community activists, number of Black people who are incarcerated, number of people incarcerated in CCB.

Not based on conditions or decisions that lead to incarceration. Uneasy with target number pulled out of the air or because of these reason; I don't know how we would know what the right number is.

Stress test—already accomplished low-hanging fruit, having a number is premature before stress test results. Would be interested to see what that number would be.

350 reduction goes to 350 supportive housing

People impacted by criminal justice system—does this include victims of criminal offenses? Wouldn't necessarily exclude victims, need to talk to committee.

New voting members—voting privilege. Who has voting privileges in CJC? Need to change other voting privileges. Recommendation came from Length of Stay workgroup.
