Presented by Marsha Mansfield, Professor of Law at University of Wisconsin-Madison. The goal is to raise the household income of 10,000 people in Dane County by 10% by 2020. Legal Interventions For Transforming (LIFT) Dane County, helps individuals to resolve civil legal problems of Dane County residents. It is a collaborative project between UW-Madison and many community partners. The project has \$1.1 million to invest. They are going to begin by focusing on driver license suspensions.

Community Service - Judicial program

Judge Bertz and Attic present: This program offers community service as an alternative to jail time, fines, or probation in certain cases. 8 hours of community service is equivalent to 1 day in jail, and 1 hour of community service is the equivalent of \$20.00 of court fines.
