An analysis of the Dane County Jail Population was presented by Jim Austin of the JFA Institute. Dane County has the potential to reduce the average daily jail population (ADP). Dane County already has a substantially lower incarceration rate compared to the national rate; therefore, Dane must look to different strategies than jurisdictions with higher incarceration rates. Dane must focus on two populations in order to reduce the ADP: those who are being transferred to a different facility, and those who are sentenced. Reducing ADP can occur through policy changes. Further work must be done to determine racial disparities within these populations.
