1. Deflection Strategies: Decriminalizing Behavioral Health Crises

Presented by: Rick Raemisch, Retired Sheriff, and Dr. Robin Timme Falcon Correctional and Community Services Inc.

Presentation about the role of treatment in public safety, since the jail is often the system to work with individuals with behavioral health issues. Options in diversion and deflection. Jail is an opportunity to connect individuals with services, particularly in reentry and care coordination. Benefits of integrated resource center for behavioral health needs.

Discussion ensued about the following topics: (1) engagement with advocates and stakeholders; (2) the total number of people who are incarcerated with mental health conditions compared to the acuteness of mental health conditions among incarcerated individuals; (3) the cost of operation and importance of data in making decisions; (4) building a new structure or using existing infrastructure.
