1. Flattening the Curve: COVID-19 in Jail Study

Flattening the Curve: COVID-19 in Jail Study Presented by Professor John Eason See attached presentation

Eason explains research design about backcasting and compares number of positive COVID-19 cases in the jail now versus what would have happened prior to decreased jail population. Discussion of decarceration moving forward and what policies can be implemented to maintain a lower jail population after the COVID-19 pandemic occurred.

Discussion occurred regarding what policies were implemented to lower and maintain the decreased jail population. Representatives from District Attorney's Office, Circuit Court Judge, Madison Police Department, Public Defender's Office, Sheriff's Office, and Department of Corrections provided feedback:

- · Collaboration and communication between different agencies
- · Release of individuals incarcerated for late child support payments
- Decreased use of bench warrants for non-appearances (since there are no in-person court appearances to not appear for)
- Proactive measures from the beginning
- · Decreased law enforcement stops that are not related to safety
- Determined alternatives to incarceration
- · Out-of-custody revocation hearings
- Identified individuals in prison who are eligible for different types of release during the pandemic
- · Technology usage
