1. CJC Members Vision For the Future of Criminal Justice

Barrett: Focus on reducing racial disparities; building trust through community engagement and transparency; using evidence-based solutions in all areas, including use of force; increasing programming in jail to provide additional supports from within the facility; maintaining some policies implemented during COVID pandemic to decrease jail population.

Parisi: Focus on providing front-end solutions to curb criminal justice involvement, since criminal justice is a reactive system. Focus on behavioral health, CAHOOTS-model crisis response team model, triage restoration center; improved services in reentry; reduction of racial disparities; collaboration towards a more equitable justice system.

Esqueda: Focus on support and growth of pretrial services in the Clerk of Courts office; using evidence-based practices to create equitable policies; collaboration between system stakeholders; maintain statutory records of court and efficiency of court process.

2. Dane County Jail Race and Ethnicity Disparity Analysis

Review of national and county trends in incarceration. Focus on distinction in decision at arrest versus incarceration/booking level. Arrest decision produces the highest level of disparity compared to other decision points. Madison Police Department participated in a "stress test" to qualitatively review a series of police/resident interactions with a wide range of community members and criminal justice stakeholders. Discussion of calls for services and the responses to those calls.

Discussion of data sources occurred; due to the Dane County CJC data sharing MOU, local data was utilized as well as Uniform Crime Reporting (UCR) data. Discussion of holds in jail. Discussion of traffic stop data, as opposed to calls for service; focus on traffic stops that involve the use of dogs. Discussion about multiple arrest offenders, and determine when they entered the system at the beginning to identify services that can be provided at that step. Discussion on ethnicity and identifying race versus ethnicity in data. Continue this research and this exercise in the future.
