## 1. Review the Lived Experience Survey and Potential Motion to Approve

*CJC-Behavioral Health subcommittee is working on a survey to understand the experiences of gaps in behavioral health services among people with lived experience of criminal justice system involvement. Subcommittee members, with staff support, have developed a survey to administer among community members to learn about the lived experience of navigating these systems and create policy and practices to provide greater supports.*

*Review of drafted survey with committee members. Committee members provide feedback on length of survey, time it will take to complete, and skip patterns in questions. Discussion of language around behavioral health treatment availability and homelessness. Committee supports moving forward with survey distribution.*

*The CARES non-law enforcement crisis response program was accepted to a cohort to receive technical assistance, coaching, and support from the Harvard Government Performance Lab (GPL). CARES would like to collect additional data, maximize capacity across the crisis care continuum, and examine opportunities for expansion.*
