C. Presentations

1. Bail Analysis - A Continued Effort in Dane County

Presented by: McNamara, Esqueda, Clark Bernhardt, and Cornelius

Reviewed past bail analysis reports. Highlighted details of the new analysis. The new analysis reviews signature bonds and cash bail events at or subsequent to initial appearance (IA) in 34,000 felony, misdemeanor, and criminal traffic cases. Key takeaways of the new analysis include:

- -Defendants in most criminal cases are released on Signature Bonds.
- -The share of felony cases that receive Signature Bonds has declined.
- -There is a significant disparity between Black defendants and white defendants with regards to who gets a Signature Bond.
- -In cases with Cash Bail, defendants paid the bail 57% of the time.

Discussion ensued on person level versus case level data and analyses. Many variables impact the analysis and what data is and is not available, and how it can be analyzed. In the future, would like Council to discuss ways the data can help inform policy and practice.

2. Initial Community Court Recommendations

Scharrer presented recommendations. See attached presentation.

Highlighted Supreme Court Rule 68 and its impact on where the community court can be located. There is currently a space in the courthouse that could be remodeled and used as the community court location.

Reviewed other recommendations relating to what pilot offenses should be reviewed by the community court, referral points, design and operations, staffing, intake and assessment process, services provided, and program and evaluation data.

Presentation also provided recommendations for the full implementation phase and how to move forward now.

Discussion ensued regarding the limitations for the location for the community court, what pilot offenses to include, and the process to petition the Supreme Court regarding SCR 68.
